**ADDITIONAL FUNDING PROVISION TO MINISTRIES, DEPARTMENTS
AND LOCAL GOVERNMENTS FOR PENSION INDEXATION AGAINST
INFLATION.**

Reference is made to your letter ref; PM 10/345/01 dated 6th October 2018 requesting for supplementary budget of Ushs 15.6bn to enable Votes effect adjustment of monthly Pension resultant from indexation to inflation. Further reference is made to your letter ref; ARC 6/135/01 dated 23rd November 2018 on submission of draft Wage, Pension and Gratuity budget estimates for FY 2019/20.

Please note that, in accordance with Section 25(3) of the Public Finance Management Act 2015 (as amended), only the Accounting Officer of a particular Vote has the responsibility of requesting for a supplementary budget under his/her Vote.

The purpose of this letter therefore, is to inform you to go ahead and automate the inflation adjustment of Pension of 5.58% as guided by the Uganda Bureau of Statistics. This should be effected in the January 2019 Pension payroll.

By copy of this letter, Accounting Officers that experience shortfalls as a result of this adjustment are requested to submit their shortfalls not later than 28th February 2019 to facilitate processing of consolidated supplementary funding.

You are further requested to ensure that you communicate the inflation adjusted Pension and Gratuity estimates for FY 2019/20 not later than 1st March 2019, to enable consolidated submission of the National Budget to Parliament by 1st April 2019, in accordance with the law.


