**BREAKDOWN OF FUNDS RETURNED AS UNSPENT BALANCES AT THE  
END OF FINANCIAL YEAR 2018/19 TO FACILITATE PREPARATION OF A  
SUPPLEMENTARY TO CATER FOR COMPLETION OF PROJECTS UNDER  
INTER-GOVERNMENTAL FISCAL TRANSFERS (UGIFT) PROGRAMME**

We issued a supplementary this Financial Year equivalent to **UgShs. 51,551,760,792** (attached letter) to Local Governments that failed to utilize all funds meant for the construction of Seed Secondary Schools and upgrade of Health Centre IIs to IIIs under Uganda Government Inter-Governmental Fiscal Transfer (UGIFT) in the Education and Health Sectors.

We received an additional **Ushs. 8,768,079,962** returned to the consolidated fund at the end of FY 2018/19 from your respective Local Governments and this Ministry is considering issuing a supplementary to enable you complete the construction of Seed Schools and/or Upgrade of Health Centre IIs to IIIs under the Uganda Government Inter-Governmental Fiscal Transfer (UGIFT) Programme for Results in FY 2018/19.

However, from the funds that were returned, we are unable to distinguish how much of the funds that were remitted are meant for completion of the above projects to enable us process this supplementary.

The purpose of this letter is to, request you to review the attached annex and distinguish how much of the funds that you remitted are meant for completion of the above projects to enable us process a supplementary to your Local Government. This information should be submitted to this Ministry by **c.o.b 31<sup>st</sup> December 2019**.

Please note, there will be no other supplementary issued for under this category in this Financial Year.

### **SUPPLEMENTARY FUNDING OF USHS.51,551,760,792/= TO CATER FOR COMPLETION OF SEED SECONDARY SCHOOLS AND UPGRADE OF HEALTH CENTRE IIS TO IIIs UNDER UGIFT**

In FY 2018/19, Government secured funding Equivalent to **US\$200m** from the World Bank under the Uganda Government Inter-governmental Fiscal Transfers Programme for Results (UGIFT) for the construction of Seed Secondary Schools and upgrade of Health Centre IIs to IIIs in sub-counties without any. These funds are allocated annually to the Local Governments, as budget support through the Sector Development Grants under the Health and Education Sectors.

The construction of the above projects started in FY 2018/19 and all the development funds were allocated by the third quarter. However, due to several challenges related to delays in procurement, a number of Local Governments were unable to utilize all the resources at the end of FY 2018/19 and, therefore, returned the unspent balances to the Consolidated Fund inline with Section 17(2) of the Public Finance Management Act, 2015.

Several Local Governments have requested that the unspent balances that they returned to the Consolidated Fund at the end of last Financial Year, be allocated as supplementary in FY 2019/20, to enable them to continue with the ongoing construction works.

Accordingly, this is to authorize a supplementary expenditure equivalent to (**Ushs.51,551,760,792**) to cater for the completion of the construction of Seed Secondary Schools (**Ushs.26,098,339,730**) and upgrade of Health Centre IIs to IIIs (**Ushs.24,445,755,004**) under the Inter-Governmental Fiscal Transfer Programme for Results under various Local Government Votes.
