BUDGET SUPPLEMENTARY FUNDING FOR LOCAL GOVERNMENTS FOR FY 2019/20

Reference is made to the concerns raised during yesterday's meeting with the Parliamentary Committee on Public Service and Local Governments regarding Local Revenue budget cuts to Urban Authorities. Further reference is made to the Appropriated Budget for FY 2019/20, where a number of issues have been raised by Local Government Accounting Officers on the same issue.

Upon further analysis of the appropriation, we noted that a number of Local Governments recurrent budgets were not appropriately captured and as such some Local Governments received higher than projected local revenue while others received less. This supplementary is meant to address the anomaly that resulted into under/ over budgeting for Local Revenue during appropriation under the various Local Government votes. Local Revenue finances activities ranging from Payment of contract staff salaries, garbage collection, Councilor's allowances, and general operational costs. Therefore, if this supplementary is not provided it will impair operations of the affected Local Governments.

In line with Article 154 (1) (2) (3), 156 (2) of the Constitution of the Republic of Uganda, I request you to authorize a supplementary expenditure of Shs. 59,249,431,699 (Fifty-Nine Billion, Two Hundred Forty-Nine Thousand Four Hundred Thirty-One Thousand Six Hundred Ninety-nine shillings) for recurrent budget for Local Revenue for those Local Governments that were affected by the cuts, as indicated in Annex 1 attach, to enable them fund implementation of several critical activities in their respective Local Governments.

This expenditure should be charged against the Local Government Votes as per the attached Annex 1.

The purpose of this letter therefore, is to request you to allow the Local Governments to include these funds over and above their budgets for FY 2019/20.
