## **EXPENDITURE LIMITS FOR THE COVID-19 EMERGENCY REQUIREMENTS FOR FY 2021/22**

1. Please refer to the letter BPD 267/268/01 dated 6<sup>th</sup> July 2021 in which the Hon Minister of Finance, Planning and Economic Development requested the Auditor General to authorize supplementary expenditure to facilitate the COVID-19 response.
2. This is therefore to communicate Expenditure Limits amounting to **US\$ 546,499,999,996 (Shillings Five Hundred Forty-Six Billion, Four Hundred Ninety-Nine Million Nine Hundred and Ninety-Nine Thousand, Nine Hundred Ninety Six Only)** allocated to various Votes to finance the supplementary expenditure. Please note that this circular does not include the release to the Ministry of Gender, Labour and Social Development which was done through a separate circular.
3. You are requested to submit your warrant requests on the Integrated Financial Management System to facilitate release of funds.
