Summary of Cumulative Receipts, disbursements and expenditure for FY 2019/20

The District had total cumulative receipts of 18,198,114bn against the total District budget of 18,677,597bn which is a budget performance of 97%. There was no release under external financing by the end of the FY which reduced the District's funding not to realize 100%. The reason was funds were released to the mother district of Mbarara and therefore we not realize any external financing funds in our budget. The other under-performance was under other government transfers of 56% where funds budgeted for were YLP and Road fund and only 1% of YLP funds were released by quarter four while funds for road fund were all released in quarter two and so there was no any road fund release in O4. The excellent performance was realized under local revenue because all the remaining funds of local revenue were all warranted by the central government in q4 and hence 100% of local revenue was received. The other highest performances were under conditional government transfers and discretionary government transfers performing at 101 and 99 % respectively reason being that funds from central government is always released 100%. The total funds disbursed to departments were 18,198,114bn which were 100% of the total receipts received. The departments that performed higher than 100% were : Planning (136%) statutory bodies (130%) administration (109%) and health (101%) reason for this higher performance was that funds for DDEG for the capital projects and transfers of DDEG for the LLGs were realized in the planning department, for statutory bodies more funds under non-wage were realized to cater for facilitating of evaluation and contracts committee meetings under procurement and disposal unit for administration more funds were for facilitating CAO's travels in co-ordination and monitoring of government programmes and for health funds were for preventing of COVID activities. The under-performance of disbursements was under: CBS (41%) and finance (54%) reason being that most of the finance activities were affected by COVID and in addition funds for UWEP community based services were not released in the whole FY. The District's expenditure was 11,494,939bn against the receipts of 18,198,114bn hence an expenditure performance of 63%. The district did not realize 100% of the expected expenditure at the end of the FY reason being that most of the development projects had not been completed such as construction of classrooms, upgrade of HCII to HCIII to effect payment and hence unspent balances. In addition most of the planned staff in the structure was not filled due to lack of the district service commission

Cumulative Performance for Locally Raised Revenues

The department had the total revenue of 734,213 m and actually received 734,213m which was 100% funds the reason for this over performance was that some of the sources over performed than the planned budget such as miscellaneous income of (295%) reason being that most of the un planned sources such as sand mining and registration fees were under this source and the collections of revenue were high due to the enforcement of collections of revenue, other fees and charges (247%) reasons for higher performance was that there was high vigilance in the collections of local revenue imposed by the revenue officers in the finance department, the other source that over performed was sale of government property (132%) reason being that the district leased public land at parish, sub-county and district and therefore more funds were realized through payment of premium . The underperformance was registered under animal related levies (18%), land fees (21%), business license (27%) reasons being that the markets were closed due to COVID and so collections of animal fees was very few for land fees the district lacks a land board since it is a new district and so land applications have not been honored and also the business licenses business activities were also affected by COVID. The other sources such as park fees, advertising fees on bill boards, inspection fees and ground rent there was no collection got from these sources for the whole FY.

Cumulative Performance for Central Government Transfers

The total revenue for the whole FY from the central government transfers was 17,209,156bn against the budget of 17,064,673 which was a slight over performance of 101% the slight increase in the releases was under sector conditional (non-wage) and this was due to the release of COVID funds which were released after the approval of the budget. The other sources such as DDEG, Sector conditional grant (wage), transitional development, pension and gratuity all funds were released 100%. We appreciate the central government for the financial and technical support that it has always rendered to our district.

Cumulative Performance for Other Government Transfers

The total receipts for the district under other government transfers were 254,746m against the budget of 458,712m which was a budget performance of 56%. The excellent performance was registered under road fund where 100% of the planned funds were released by the end of quarter two. The other source of YLP only 1% was released in the whole FY. The benefiting groups were receiving direct funds from the ministry of gender and only 1% funds released to the district were for monitoring of the benefiting groups.

Cumulative Performance for External Financing

In the whole FY, the District did not receive any funds for external financing reason being that funds under global fund were released to the mother district Mbarara and so there was no any release made to Rwampara District Local Government. The activities in the district would be implemented by Mbarara District.

Summary of Workplan Revenues and Expenditure by Source

The department had a cumulative revenue of 2,564,340 bn against the budget of 2,353,115bn which is a budget out-turn of 109%. The over performance was registered under multi-sectoral transfers (252%) and Non-wage (126%) reason being that warrants for multi-sectoral transfers especially for the cumulative quarters were higher than what was budgeted for in the quarters and for nonwage the warrants prepared were higher than the expected quarterly budgets reason being funds were for activities of monitoring and orientation of communities on government programmes being a new district. While the department performed poorly under local revenue with (88%) reason being that most of the funds under local revenue were not yet exploited and so allocations of funds to departments was limited. The department had a cumulative expenditure of 539,531m which a cumulative expenditure performance of 21%. The reason for this under performance in expenditure was that few staff were paid compared with what was budgeted for since there was no recruitment at all in the last FY. The district did not have its own service commission and more so the process of getting a service commission from other Districts was affected by COVID. In addition pension and gratuity for the retired staff had not been fully paid since there was still transition of pensioners details from Mbarara District to the new district of Rwampara. For quarter four the department had a revenue of 391,265m against the quarterly budget of 1,036,233bn which is a quarterly budget performance of 38% the reason for this under performance was that the development funds especially for the construction of the administration block was released up to 3rd quarter there was no any development release in Q4. However there was some over release under local revenue (140%) Non-wage (132%) reason being that funds were for monitoring of development projects before the final payments made at the end of the FY. The lowest release was under multi-sectoral transfers (23%) reason being that more funds were released in the previous quarters what was released in Q4 was the remaining funds. The expenditure for O4 was 287,318m which was an expenditure performance of 73%. The over performance in expenditure was under non-wage (120%) reason being funds for monitoring and implementation of government programmes by administration department especially at the end of the FY. The unspent funds were 2,024,809bn composed of wages (537,435m) non-wage (462,142m) and development (1,025,232bn) reasons being that for wages few staff were paid compared to those budgeted for due to lack of a district service commission, non-wage most of the funds were for pension and gratuity where payments were not yet effected since transition of files of some pensioners from the mother district were not yet finalized to pay them. While development funds these were funds for construction of administration block and works had not been completed although funds were committed and payments would be effected in the coming FYs budget.

Reasons for unspent balances on the bank account

The unspent funds were 2,024,809bn composed of wages (537,435m) non-wage (462,142m) and development (1,025,232bn) reasons being that for wages few staff were paid compared to those budgeted for due to lack of a district service commission, non-wage most of the funds were for pension and gratuity where payments were not yet effected since transition of files of some pensioners from the mother district were not yet finalized to pay them. While development funds these were funds for construction of administration block and works had not been completed although funds were committed and payments would be effected in the coming FYs budget.

Highlights of physical performance by end of the quarter

Payment of Staff Salaries, Monitoring of government programmes, Payroll Printing, Ensuring Staff to access the payroll, Ensuring Salary enhancement for teachers. Monitoring of government programmes and provision of accountability through public Barazas. Payment on some works at the construction of the administration block.

The department had a cumulative revenue of 397,787m against the budget of 743,065m which is a budget out-turn of 54%. The over performance was registered under non-wage (104%) reason being that more funds were released to carry out co-ordination of IFMS activities and facilitation of travels to LLGs to compile data for preparing the final accounts while the department performed poorly under local revenue with (49%) reason being that most of the funds under local revenue were not yet exploited and so allocations of funds to departments was limited. The department had a cumulative expenditure of 92,140m which a cumulative expenditure performance of 23%. The reason for this under performance was that assessment of local revenue especially on property rates was not yet implemented the activities were affected by COVID and for wages few staff were paid for in the FY compared with what was budgeted for since there was no recruitment at all in the last FY. The district did not have its own service commission. The department had total unspent funds of 305,647m which was composed of wages (79,298m) and non-wage (226,349m) the reasons for this unspent was that for wages few staff was paid for in the FY compared with what was budgeted for since there was no recruitment at all in the last FY. The district did not have its own service commission and for non-wages the underperformance was that assessment of local revenue especially on property rates was not yet implemented the activities were affected by COVID while for Q4 the department had revenue of 50,567m against the quarterly budget of 185,766m hence a quarterly release of 27%. The over performance was registered under non-wage to carry out implementation of IFMS activities and the underperformance was under local revenue (10%) reason being that most of the collections of local revenue were affected by COVID. The quarterly expenditure was 33,077m hence a quarterly expenditure performance of 65%. The underperformance in expenditure was under non-wage reason being that funds were for carrying out assessment of local revenue especially property tax and this activity was affected by COVID.

Reasons for unspent balances on the bank account

The department had total unspent funds of 305,647m which was composed of wages (79,298m) and non-wage (226,349m) the reasons for this unspent was that for wages few staff was paid for in the FY compared with what was budgeted for since there was no recruitment at all in the last FY. The district did not have its own service commission and for non-wages the underperformance was that assessment of local revenue especially on property rates was not yet implemented the activities were affected by COVID

Highlights of physical performance by end of the quarter

Summary of Workplan Revenues and Expenditure by Source

The department had a cumulative revenue of 476,506m against the budget of 365,690m which is an over budget out-turn of 130%. The over performance was registered under local revenue of (579%) and wage (101%) reason being that funds under local revenue were for payment of all arrears for district councilors emoluments before the end of the FY and for wages funds were for payment of salary arrears for political leaders especially the executive members at both higher local government and lower local government who had accessed payroll in quarter. The cumulative expenditure was 129,286m which was an expenditure performance of 27%. The reasons for this under performance is that the staff paid salaries are less than those who were budgeted for reason being that recruitment of technical staff did not take place in the previous FY due to lack of the district service commission. Non-wage also under performed because not all the allowances for political leaders meetings were paid since most of the meetings were not held due to the effects of COVID. The department had total unspent funds of 347,215m composed of wages (99,248m), non-wage (247,972m) reasons for this unspent is that there was no recruitment for the departmental staff as it was budgeted for due to lack of the district service commission and for non-wage funds for political leaders allowances for attending meetings was affected by COVID and also the budget for honoraria and ex-gratia was higher than the political leaders in the district. While for Q4 the department had revenue of 212,477m against the budget of 86,545m which is an over budget release of 232% reason for the over release was under local revenue (1991%) wage (106%) reason being that funds under local revenue were for payment of all arrears for district councilors emoluments before the end of the FY and for wages funds were for payment of salary arrears for political leaders especially the executive members at both higher local government and lower local government who had accessed payroll in quarter four. The departmental expenditure was 86,545m which is an expenditure performance of 41%. The reasons for this performance is that most of the recurrent activities for the department were affected by COVID and also few staff were paid salaries compared to the ones budgeted for since there was no recruitment in the district.

Reasons for unspent balances on the bank account

The department had total unspent funds of 347,215m composed of wages (99,248m), non-wage (247,972m) reasons for this unspent is that there was no recruitment for the departmental staff as it was budgeted for due to lack of the district service commission and for non-wage funds for political leaders allowances for attending meetings was affected by COVID and also the budget for honoraria and ex-gratia was higher than the political leaders in the district.

For Q4 the department received 214,339m against the quarterly budget of 234,826m which is a budget release of 91% and the reasons for this performance is that wage and sector non-wage were allocated to departments without conditional grants from the central government. The quarterly expenditure for the department was 118,996m which is a quarterly expenditure of 56% the reason for this performance is that few staff were paid in the department compared to those budgeted before since the district lacked service commission also non-wage activities were affected by COVID for example the annual agricultural trade show.


