Quarter 4**Summary of Cumulative Receipts, disbursements and expenditure for FY 2023/24**

By the end of the FY 2024/25, Mubende Municipal Council cumulatively received a total of UGX 38,077,778,000 out of the total revised Budget of UGX 38,924,428,000 representing 98% of the Budget performance and over 100% of the approved budget. Except the external financing and other government transfers, other sources performed to at expectation with Locally raised revenue and Government transfers at 100%.

The external financing, performed low because the project was approved late in the financial year. This has been extended to the following FY, the project of the biogas has been scheduled for three years.

The other government transfers performed poorly because funds meant for low cost sealing from URF were not released by the concerned agency.

Out of the total receipt, UGX 37,900,329,000 was spent representing 99.5% of the receipts being spent. Some monies remained unspent in the locally raised revenue relating to the month of June since, the MOFPED had not yet released it by close of business of the reporting Financial Year. Also some monies remained in departments for activates not executed. Generally, the Municipal budget outturn, disbursement and expenditure was satisfactory since in all it was over 99%.

Quarter 4**Cumulative Performance for Locally Raised Revenues**

By the end of the FY, the Municipality had cumulatively collected a total of UGX 1,574,783,000 which is slightly above the annual Budget. Funds relating to the Month of June were not received from the MOFPED, so there was no need of a supplementary. This money remained undistributed to departments. .

Cumulative Performance for Central Government Transfers

By the end of the FY, the Council had received a total of UGX 10,360,273,000 as conditional grant representing 100% of the revised budget and UGX 25,638,687,000 as Discretionary transfers performing at 100%. Generally, the Central Government's Commitment to the Municipal budget performed as expected. This is because of USMID and other development funding which is received in the first three quarters of the Year was fully released.

Cumulative Performance for Other Government Transfers

By the end of the fourth quarter of the FY, the council had received only UGX 423,726,000. This was only 56% of the Annual Budget. Source like UWEP and URF yielded below the target due to unexpected budget cut. These contributed to that poor budget outturn.

Cumulative Performance for External Financing

No funds received during the Quarter, however the total amount received throughout the FY was UGX 80,309,000

Summary of Department Revenues and Expenditure by Source

By the end of the FY, the department had cumulatively received shs. 2,706,864,000 out of the AB of shs. 2,018,515,000 & RB of shs. 2,719,311,000 making an outturn of 134% & 99.5% respectively. This is on target & attributed to supplementary of Programme Conditional Grant Non – Wage, Unconditional Grant at 108%, Urban Unconditional Grant Wage at 148%, performance of multi sector transfers to LLGs. However, the department registered poor performance under local revenue at 67%.

By the end of the FY, the department had cumulatively spent shs. 2,661,764,000 making a 132% & 98% budget absorption against the AB & RB respectively. Q4 expenditures are slightly higher than the outturn & this is attributed to revenues that were received in the previous quarters & expenditures made in Q4. Expenditures were made on payment of salaries, pension, gratuity, office management, supervision, support to the PDM program, town order, routine monitoring & management of the Municipality.

Reasons for unspent balances on the bank account

Shs. 44,989,000 remained on account unspent meant for salaries that weren't consumed.

Highlights of physical performance by end of the quarter

Payment of salaries, award of contracts, 12 technical planning committee meetings held, town order maintained, 4 monitoring sessions held and profiling of Households for the Parish Development Model program, PDM beneficiary identification meetings, and provision of support for imbursement of funds.

This is almost on target and attributed to on target performance of all sources of revenue to the department except for locally raised revenues at 93%.

By the end of the financial year, the department cumulatively spent shs. 314,680,000 making a 97% budget absorption against the approved budget. During the fourth quarter, 124 million was spent out of the received 116 million and this was because some expenditures made were out of revenues received in the previous quarters.

Expenditures were made on payment of salaries, quarterly revenue enhancement activities, collection and sport checks, management of the IFMS, preparation and submission of financial, accountability reports and support to divisions.

By the end of the FY, the department had cumulatively received a total of shs. 166,351,000 out of the AB of shs. 111,451,000 & RB of shs. 177,860,000 making a budget outturn of 149% & 94% respectively. The performance seems above target but Program Conditional Grant Non – Wage Recurrent had not been appropriated at approval. Therefore, the RB performance of 94% provides a better picture for the department. This general FY performance is slightly below target and attributed to poor performance of OSR at 42% cumulatively. Other sources of revenue to the department were on target. By the end of the FY, the department cumulatively spent shs. 163,873,000 making a 147% & 92% budget absorption against the AB and RB respectively. Expenditures were made on payment of salaries, sensitization of communities for PDM, training of enterprise groups in EKIBAALO, conducting demonstration farms, immunizations, advisory services, provision of agricultural extension & veterinary services.

Reasons for unspent balances on the bank account

Shs. 2,477,000 was left on account unspent as wage balances that could not be consumed.
