Summary of Cumulative Receipts, disbursements and expenditure for FY 2025/26

The annual budget for Council was shs 23,479,740,000 later revised to shs 25,404,920,000 and cumulatively received shs 11,185,924,000 which is 48% of the annual budget. Local revenue performed poorly at 36% of the annual local revenue budget due to off peak season. Discretionary government transfers performed at 50% of annual budget. Conditional Central government transfers performed well at 49%. Other Government transfers over performed at 66%. On the side of expenditure, programmes received a release of shs 8,856,847,000 which is 38% of the annual budget and was utilized as follows shs 5,667,789,000 was spent on wages at an absorption capacity of 46% then shs 3,019,600,000 spent on nonwage at absorption capacity of 35% then shs 169,458,000 on development at absorption capacity of 7%. Governance and Security programme performed fairly due to transfers to divisions, Human Capital Development, Tourism Development and Public sector transformation programme performed fairly well. The rest of the programmes performed poorly due to low local revenue collections. Sustainable urbanization performed worst because processing of land titles was initiated late.

Cumulative Performance for Locally Raised Revenues

Kabale municipal council has an annual local revenue budget of shs 3,370,268,409,000 and had planned to raise shs 842,567,099 as local revenue in Q2 but realized shs 580,202,762 which is 68.9% of the quarterly planned revenue and cumulatively realized shs 1,201,558,272 which is 36% of the annual planned local revenue collections, local service tax, liquor license, miscellaneous Property tax, and land fees performed well, The rest under performed due to tax defaulting, avoidance and weak enforcement to ensure compliance.

Cumulative Performance for Central Government Transfers

Kabale Municipal Council has an annual budget of shs 19,809,623,713 from Central Government transfers and had planned to realize shillings 4,952,405,928 in quarter two but ended up realizing shs 5,169,979,485 which is 104.3% of the quarterly planned revenue and cumulative transfers shs 9,787,007,731 which is 49.4% of the annual planned revenues. All planned revenues were received. The deviation between quarterly planned and actual revenue received from Central Government was due to;

1. Adjustments made on release of development funds in only two phases.

Cumulative Performance for Other Government Transfers

Kabale Municipal Council has annual budget of shs 299,847,517 under OGTs and planned to realize shs 86,211,879 in quarter two but ended up realizing shs 153,224,319 which was from URF and PLE UNEB exams. The cumulative receipt of OGTs amounts to shs 197,358,465 which is 85.9% of annual budget of OGTs.

The deviation between planned and actual was due to persistent poor recovery of YLP funds due to disappearance of beneficiary groups.

The department spent shs 1,287,200,000 in Q2 and cumulative expenditure was shs 2,390,449,000 representing 40% of annual budget of which wages shs 138,768,000 and nonwage activities shs 2,156,507,000 then development DDEG shs 95,174,000 leaving an unspent balance of shs 109,554,000. The deviation between planned and actual performance was due to; 1. staff planned for but not recruited in time. 2 pension files verification not completed in time. 3. Poor performance of local revenue collections.

Reasons for unspent balances on the bank account

The unspent balance of shs 109,554,000 is mainly composed of Gratuity and pension due to ongoing verification of retirees files.
