Summary of Cumulative Receipts, disbursements and expenditure for FY 2025/26

During quarter 2, Kitgum MC - vote 714 received an aggregate revenue of UGX. 5,014,601,000. This was 47% of the approved budget. Of the total release, Discretionary Government Transfers (DGT) was UGX. 835,942,000 (46% of it's approved budget), Conditional Government Transfers (CGT) was UGX. 3,621,947,000(48% of it's approved budget), Other Government Transfer (OGT) was UGX. 151,310,000(70% of it's approved budget) and lastly local revenue was UGX. 405,401,000(36% of it's approved budget).

Overall, there is a variation in the total receipts reflected by a shortage of 3% under-performance during the quarter 2 implementations. The shortfall in the revenue was attributed to by under release in the Discretionary Government Transfers reflecting 4% deficit, Local revenue reflecting 14% deficit and greatly CGT with a deficit of 2%.

By end of quarter 2, the institutional aggregate expenditure was UGX. 4,399,249,000(41% of the approved budget). Out of this, wage expenditure amounted to UGX. 2,289,820,000(46% of it's approved budget), Non-wage expenditure amounted to UGX. 1,880,651,000(41% of it's approved budget) and lastly Domestic Development of UGX. 228,778,000(19% of it's approved budget).

Cumulative Performance for Locally Raised Revenues

The collection for quarter 2 was UGX. 405,401,000 representing 36% of the approved local revenue approved budget. Noted was a variation of 14% shortfall in the revenue collection.

This has been caused by inadequate enforcement of the revenue frontliners, low motivations, suspected leakages and professionalism deficiency in revenue collection. This affected major sources of property tax, business licenses, local hotel tax, building permits among others.

Cumulative Performance for Central Government Transfers

During quarter 2, Kitgum MC - vote 714 received an aggregate revenue of UGX. 5,014,601,000. This was 47% of the approved budget. Of the total release, Central Grant only constituted UGX. 4,609,200,000(92%); Discretionary Government Transfers (DGT) was UGX. 835,942,000 (46% of it's approved budget), Conditional Government Transfers (CGT) was UGX. 3,621,947,000(48% of it's approved budget), and Other Government Transfer (OGT) was UGX. 151,310,000(70% of it's approved budget).

Overall, there is a variation in the total receipts reflected by a shortage of 3% under-performance during the quarter 2 implementations. The shortfall in the revenue was attributed to by under release in the Discretionary Government Transfers reflecting 4% deficit, Local revenue reflecting 14% deficit and greatly CGT with a deficit of 2%.

Cumulative Performance for Other Government Transfers

During quarter 2, our vote received a total Other Government Transfer (OGT) of Ugx. 32,532,246. It represented 15% of the approved budget of this grant category.

A shortfall in the overall grant performance was noted as indicated by 10%. This came as a result of under release of URF, no release of PLE, GROW and UWEP & YLP operational grants during the quarter 1 implementation.

The unspent balance was UGX. 62,323,000.

Non-wage of UGX. 25,462,000; meant for activities carried forward.

Wage of UGX. 1,212,000; remains due to over-budgeting.

During Q2 the department received cumulative total release of 474,128,000 UGX (50%). Of these, 221,769,000 UGX (50%) for wage, 48,699,000 UGX PHC NWR (50%), 7,698,000 (38%) locally raised revenue, 194,617,000 UGX (50%), 1345,000 UGX (26%) urban DDEG.

There is no variation in the department as per the expected 50% release by this quarter.

The department had cumulative expenditure of UGX 282,565,000 UGX(30%). Out of this, wage expenditure was UGX 218,428,000, NWR expenditure was UGX 56,397,000 and development expenditure was UGX7,740,000.

Reasons for unspent balances on the bank account

The total unspent fund was UGX 191,563,000. Out of this, wage constituted UGX 3,341,000; it was meant for salary of some health staff who missed payment during the quarter. Unspent development UGX 188,221,000 awaiting conclusion of procurement processes.

Highlights of physical performance by end of the quarter
