Summary of Cumulative Receipts, disbursements and expenditure for FY 2025/26

Njeru Municipal Council Cumulative receipt for Quarter two is 8,649,431,000/=, representing 48% performance against Annual Budget of 18,139,466,000/= of which Cumulative Central Government Transfers received is 6,814,116,000/= against the Annual budget of 14,209,307,287/=, representing 47.9% performance. And Cumulative Local Revenue received is 1,675,679,000/=, representing 46% performance against Annual Budget of 3,666,103,881/=. For Other Government Transfers receipts is 159,637,000/=, representing 60% performance against approved budget. Slight under performance is from unrealized Local Revenues from some revenue sources like Market dues, Environment levy, Animal levy and Advertisements/ Bill Board fees.

All the cumulative receipt of 8,649,431,000/= was disbursed to the departments to implement planned activities in the departments.

Total Cumulative Expenditure is 7,489,530,000/=, representing 41% of the Approved Annual Budget of 18,139,466,000/=. This leaves total unspent balance of 1,234,874,000/=, to be utilized in the subsequent quarters. This is because most capital projects where pending finalization of the procurement process to commence work and which is the case of funds accumulated for the procurement of a grader and land for the dumping site.

Cumulative Performance for Locally Raised Revenues

Njeru Municipal Council Cumulative Local Revenue received by quarter two is 1,675,679,000/=, representing 46% performance against Annual Budget of 3,666,103,881/=.

The short fall is due to; Late issue of demand notes for the Advertisement fees and low compliance from Animal dues and Environment tax, low receipts from market dues because some markets are not contracted making it difficult to manage the levies from them.

Cumulative Performance for Central Government Transfers

Njeru Municipal Council Cumulative Central Government Transfers received by quarter two is 6,814,116,000/= against the Annual budget of 14,209,307,287/=, representing 48% performance.

The slight deviation from planned is from Sector Conditional Grants at 43%, which was not released as planned.

Out of the total cumulative receipt of Central Government transfers, Discretionary Government Transfers was 1,037,944,000/=, representing 50% performance, And Conditional Government Transfers received is 5,776,172,000/=, representing 48% performance against annual budget.

Cumulative Performance for Other Government Transfers

Njeru Municipal Council cumulative receipt for Other Government Transfers is 159,637,000/=, representing 60% of the approved Budget of 264,055,000/=. This is slightly over performance by 10% as released from the center.
