INVITATION TO ATTEND THE GOVERNMENT ANNUAL PERFORMANCE REVIEW (GAPR) FOR THE FY 2020/2021 AND THE NATIONAL BUDGET CONFERENCE FOR THE FY 2022/23

Reference is made to the Prime Minister's letter Ref: ADM/133/01 dated 3rd August 2021 on the above forthcoming Government Annual Performance Review for the FY 2020/21.

The Review is scheduled to take place from 7th -8th September 2021 at the Office of the President Conference Hall, followed by the National Budget Conference by the Ministry of Finance, Planning and Economic Development on the 9th /September 2021 to be held at the Kololo Independence Grounds.

The Review for FY 2020/21 shall focus on strides made towards achieving the National development priorities for the year under the theme "Stimulating the Economy to Safeguard Livelihoods, Jobs, Businesses and Industrial Recovery".

The National Budget Conference is held in accordance with the provisions of article 155(1) of the Constitution of the Republic of Uganda and section 13(2) of the Public Finance Management Act 2015 (Amended) that requires the Ministry of Finance, Planning and Economic Development to start the planning and budgeting consultation process for the FY 2022/23. The Theme of the budget for the next Financial Year will be "Industrialization for Inclusive Growth, Employment and Wealth Creation". The Conference will focus on;

1. The Budget Strategy and Government Policy Intervention Areas for FY 2022/2023, and
2. The economic progress; key challenges to economic growth and development during the first phase of the National Development Plan (NDP) III period and the proposed way forward amidst the COVID -19 Global pandemic.
