You are further reminded that the NTR returns for July-September, 2015 should have evidence of transfers of all revenue collections as **at the end of each respective month** to the revenue account in Bank of Uganda.

In line with the Budget Execution Circular for FY 2015/16, you are reminded to adhere to the timelines in submission of performance reports for the funds released to you following the Output Budgeting Tool (OBT) format but in any case not later than 30th January 2016.

Accountability
