V2: Past Vote Performance and Medium Term Plans

Performance for Previous Year FY 2018/19

- 1. Participated in the third triennial review of the Agreement on Technical Barriers to Trade in the Committee on Technical Barriers to Trade and submitted and defended proposal for the establishment of a Standards and Trade Development Facility at the WTO from which Uganda as an LDC can obtain technical assistance and capacity building for Ugandans on the implementation of the TBT Agreement and help Ugandan exporters gain and maintain access to intentional markets.
- 2. Participation in Services Trade in WT/L/982 with the aim of creating awareness among Ugandan services suppliers in particular of the preferential treatment accorded to them in accessing foreign markets such as lower or no visa fees etc.
- 3. Participated in the 6th Meeting of the Uganda National Reference Group under PACT EAC2 to share insights with stakeholders on how Uganda can leverage opportunities in the Committee on Agriculture and the Committee on Agriculture in Special Session.
- 4. Facilitated the visit of ILO Mission to Uganda (May 2018) to follow up on integrated strategy to address decent work deficits in tobacco. The strategy has three central goals: a) to promote an enabling policy environment for decent work in tobacco-growing countries; b) to strengthen social dialogue; and c) to assist tobacco-growing communities to address decent work deficits, including child labour, including through a transition to alternative livelihoods. In Uganda over 130,000 children and their families in tobacco growing communities notably Hoima are benefiting from Elimination of Child Labour in Tobacco project (ECLT) that is funded by PPP between Tobacco Industry and ILO.

Solicited for three capacity building sponsored slots from UNCTAD in Fisheries sector, for Uganda to participate in the First regional training course on harnessing the potential of the fisheries sector slated to take place at the Asia Regional Centre of Excellence for Fisheries Development, Nha Trang University, Vietnam.
- 11. Issued 381 travel documents into Uganda and 3 emergency travel documents.
- 12. Handled 2 consular cases of Ugandan communities in Switzerland, facilitation and recommendation of issuance of new passport and renewal, verification of Documents.
- 13. Held discussions with the Executive of the Association of Ugandans living in Geneva to sensitize them on requirements for issuance of national ID.
- 14. Successfully repatriated one Ugandan, Mr. Alex Ali Galiwango after voluntarily accepting to return home under the voluntary return assistance program by the Swiss government.
- 15. Participated in the Friends of SDG Financing meeting in Zug at the invitation of the Canadian Mission to explore means through SDG related financing is mobilized.
- 16. Continued discussions with one Swiss exporter of medical supplies who still has technical queries to be resolved with the SGS Uganda. SGS international requirements.
- 17. Facilitated a consultancy company (Invest-Partners, Wealth Management AG) that wished to undertake an exploratory trip to the Ministry of Finance in Uganda. The company is heavily involved with training bankers and executives in government in various aspects of finance and change management.
- 18. Efficiency of Vote Budget Allocations

The Mission has been funded 50% of the entire budget for Financial Year 2019/20. More funds are required on major lines like Rent, Allowances, salaries, and all fixed item lines

Vote Investment Plans

Capital investment is required in line with Purchase of new Furniture for both the Official Residence and Chancery, and the procurement of a property to house the Chancery would help to cut the cost of Rent by about ½

Major Expenditure Allocations in the Vote for FY 2020/21

Major expenditure allocations are required on Capital Development in order for the chancery to be able to purchase its own building, resultantly enhancing the Uganda's image abroad and reduction in costs incurred on rent.

V5: VOTE CHALLENGES FOR 2020/21 AND ADDITIONAL FUNDING REQUESTS

Vote Challenges for FY 2020/21

- I. Delayed releases and currency fluctuations. Late settlement of mission bills has continued to attract late payment penalties and negatively affects the Mission's reputation in case of rent bills and image of the country at large.
- II. Low staffing levels has affected the Mission performance in general. The Mission is composed of 1+6 staff and expected to cover over 33 International Organisations, of which, 23 are inter-governmental agencies. Among them, are 8 UN agencies. There are also about 250 Non-Governmental organisations headquartered in Geneva.. Additionally, the Mission takes care of the bilateral relations between Uganda and Switzerland.
- III. High cost of living as compared to the non-competitive remunerative rates in terms of Foreign Service Allowances, Salaries and Wages. Local staff salaries are not reflective of the baseline.
- IV. The vote receives limited operational funds and therefore, most of the funds go to paying fixed costs.
- V. The Vote continues to be housed in a rented property and this money could be allocated to procure a property through innovative avenues such as mortgaging so that we avoid paying exorbitant fees in rent.
- VI. The stringet labour laws of the host country in regards to retirement and payment of gratuity.
- VII. It is very difficult to Dispose off items at the Mission due to the terms put accross by the Host Country, hence failure to dispose them off according to the recommendations of Board of Survey and in line with the PPDA Act.
