I. Vote Mission Statement

III. Major Achievements in 2019/20

- Held a meeting with officials from the African Leather and Leather Products Institute on its activities and how Uganda can benefit from the Institute especially in skilling the youth.
- Coordinated and participated in the 3rd Ethiopia-Uganda Joint Ministerial meeting 14th-16th August 2019. Outcomes of the JMC include: An MOU on Investment is to be concluded between Uganda and Ethiopia; Dairy and dairy products, Sugar, Coffee, Pharmaceuticals, Cereals, Beef and beef products and plastics proposed as potential list of Ugandan products for export to the Ethiopian Market; Uganda to consider export of education services i.e. English language teachers to Ethiopia within the framework of the MOU on Education.

X. Vote Challenges and Plans To Improve Performance

Vote Challenges

- Addis Ababa is a unique Mission from other multilateral diplomatic missions. While other Missions handle a work program that is scheduled, Addis Ababa handles a lot of unscheduled summits and meetings in its different areas of accreditation. This has a huge effect on the mission's financial resources and renders them insufficient e.g. in the preceding years; the mission handled 7-12 summits per year.
- Inadequate human resource to fully cover activities and meetings in the mission's areas of accreditation i.e. AU, IGAD, UNECA, Ethiopia and Djibouti.
- Besides inability to cover essential meetings/engagements the underfunding and staffing constraints as well as diminishing staff morale, undercut the execution of the mission's mandate and undermine the effective pursuit of national interests.
- Low staff emoluments yet the Mission is situated in a hardship environment (We propose that the mission is elevated to group A)

Plans to improve Vote Performance

- Lobby for increased funding for the Mission especially on Travel Abroad
- Enhancement of Human Resource Staffing Levels
- Secure the Chancery and official residence with CCTV Cameras and other access security devices including two walk through and two hand held metal detectors
