I. Vote Mission Statement

The Mission of the Permanent Mission is to represent Uganda and effectively participate in the work of Geneva based International Organizations such as the UNO, WTO, UNCTAD, ITC, ILO, WIPO, WMO, OHCHR and UNCHR, WHO, ITU; to promote Uganda as a major tourist and profitable destination for Swiss tourists and Foreign Direct Investment respectively; to enhance the value, volume and diversity of Uganda's exports to the international market; and to mobilize financial and other resources from Switzerland to Uganda.

II. Strategic Objective

To promote and Protect Uganda's Interests in Switzerland and represent Uganda and effectively participate in the work of Geneva based International Organisations.

III. Major Achievements in 2020/21

- 1. Defended human rights record of Uganda at the 46th Session of the HRC that took place in the aftermath of Uganda's national elections as well as against UNAIDS report Rights in a pandemic accusing the government's Covid-19 Public Health Measures accusing government of violating human rights in the due course including inaccessibility to medicine for people living with HIV AIDS, pregnant mothers, sick and apparent discriminative arrests of LGTBI respectively.
- 2. Jointly collaborated with Austria, Honduras and the Office of the High Commissioner for Human Rights to host an intersessional seminar on Internal Displacement and launched a stocktaking report on the Implementation of the Plan of Action for Advancing Prevention, Protection and Solutions for Internally Displaced Persons 2018-2020. Uganda shared lessons learnt in this regard
- 3. Participated in the UNHCR High Commissioner's Dialogue on Protection Challenges which made recommendations to UNHCR to strengthen protection mechanisms across the world. Uganda was particularly, commended for opening asylum space during the pandemic to Congolese asylum seekers.
- 4. Jointly cosponsored with Norway and UNHCR the clean energy challenge in refugee camps, and specifically, called for the inclusion of clean energy in the humanitarian programme budgets to promote local response to clean energy thus mitigating on deforestation and its associated effects on the climate.
- 5. Coordinated the visit of the United Nations High Commissioner for Refugees to Uganda in March 2021, creating international awareness and support for the plight of refugees.
- 6. Joined ranks with Africa group position in negotiations to advance: Development of WHO Equitable Framework to ensure that all countries have equitable access, and provides a safeguard formula for distribution of Covid-19 vaccine once developed; Call for broad based reflection in the top structure of the IOM; Implementation of the Human Rights Council Resolution A/HRC/43/1 on the promotion and protection of human rights and fundamental freedoms of Africans and the people of African descent against excessive use of force and other human rights violations by law enforcement officers.
- 7. Successfully lobbied for UNCTAD capacity building project on Promoting Refugee and Migrant Entrepreneurship in East Africa, the Andean region and the Middle East. The objective of the project is to strengthen the capacity of the government to formulate and implement policies and measures to leverage entrepreneurship for addressing issues of migration with an ultimate goal of fostering socio-economic integration and cohesion in line with 2030 Agenda.
- 8. Participated in the selection process of the WTO DG that witnessed the appointment of the first African Woman, Dr Ngozi from Nigeria.
- 9. Effective representation of Uganda and Africa in key organisations namely, Deputy Member of the ILO Governing Body as well as Vice Chair, WIPO Coordination Committee for the Biennium 2020/2021.
- 10. Promoted Uganda candidatures that included; Uganda's election as a member, representing Africa on the Technical Working Group on the democratisation of the ILO; Facilitated the nomination and extension of term of office of Ms Beatrice Florence to the Bureau of the Working Party of UNECE; strategizing Uganda's election and subsequent elevation from Deputy to Regular member of the Governing Body of the ILO at the forthcoming elections in June 2021; Judge Dr Julia Sebutinde for re-election at the ICJ under a reciprocal arrangement for Switzerland's bid for non- permanent seat at the UNSC (2022-2024).
- 11. Capacity building of staff by facilitating three officers to undertake French language course to improve on their effectiveness and efficiency.
- 12. UNCTAD has continued extending technical assistance to Uganda in the area of Debt Management and Financial System Program thus supporting the latter to build capacity on national debt management.
- 13. Secured a 10 month's fully funded French-Irish Mission Internship Program for one capital based government official effective March 2021. This program is meant to build the capacity of officials from various government MDA's in the work of the WTO.
- 14. Secured 2 undergraduate/graduate scholarships from Azerbaijan under the educational grant program for citizens of Member

States of the OIC and 4 capacity building Opportunities (two from WTO, one from WIPO and one from UNECE).

Promotion of Trade, Investment and Tourism

- 15. Hosted a virtual desk at the Africa Business Day with the support of the Uganda Investment Authority, show casing Uganda's investment and tourism potential. The event among others brought together 30 participating countries; 9 Swiss Ambassadors accredited to various African countries; and 7 African Ambassadors accredited to Switzerland. Uganda's virtual desk received 12 profile views, 18 chats with clients, 11 products and video views; and Brochures were down loaded 34 times. The permanent Mission is following up on three prospective investors in energy solutions, solar energy and housing that showed interest in investing in Uganda.
- 16. Participated in finalisation of the Group 77+China negotiating text for the upcoming UNCTAD 15 conference, later in the year. Critical issues advanced by the Group under the three major pillars of consensus building; research and analysis and technical assistance include sovereign debt management and restructuring; promoting of multilateral economic and trading System; structural transformation; plugging illicit financial flows to boost domestic resource mobilisation; new aid architecture; digital divide.
- 17. Following up with UNCTAD on the establishment of carbonized briquette technology in conjunction with Uganda Industrial Research Institute, under the UN Development Account disrupted by the Covid-19 pandemic.
- 18. Joined consensus to support South Africa and India's joint proposal entitled "Waiver from certain provisions of the TRIPS Agreement for the Prevention, Containment and Treatment of Covid-19" submitted to the TRIPS Council. The idea behind is to ensure that IP rights do not impede access to diagnostics, medicines, vaccines and other medical technologies needed to contain COVID-19.
- 19. Participated in the Council for TRIPS and defended the LDC proposal on the implementation of Article 66.2 of the TRIPS Agreement aimed at the effective realization of technology transfer to LDCs like Uganda; and extension of the transition period with maximum flexibility under the TRIPS Article 66.1 to allow time to build a sound and viable technological base thus avoiding retaliation for non-compliance with the TRIPS obligations to provide intellectual property protection.
- 20. Remained engaged in negotiations for an extension of the TRIPS Transitional Period for pharmaceutical products until graduation with flexibilities upon graduation. Uganda and CIPLA pharmaceuticals producing antiretroviral drugs for the over 1.4m people living with HIV/AIDS directly benefit from this extension.
- 21. Continued engagement in market access negotiations at the WTO including: advocating in the Council for Trade in Services for stock-take benefits for the LDCs services waiver which offers services and service providers form LDCs preferential treatment in markets of WTO members that have notified preferences in specific sectors; negotiations for a permanent solution on Public Stockholding for Food Security that favour Uganda to enable us have recourse on using the food security provision should need arise; duty-free and quota free (DFQF) market access to products originating in LDCs like Uganda to ensure that products of export interest to Uganda are included and guard against preference erosion, technical assistance to build capacity of the cotton sector to be benefit from multilateral cotton trade; TBT Agreement to enable Ugandan exporters gain and maintain access to intentional markets.
- 22. Organised a webinar on Covid-19 measures and services trade in the capacity of focal point on services for the WTO LDC Consultative Group, generating insights into the state of play, challenges, solutions and opportunities occasioned by Covid-19. It underlined the relevance of digitalisation on the road to recovery.
- 23. Uganda in her capacity as the focal point on services for the WTO LDC Consultative Group, organised a webinar on Covid-19 measures and services trade generating insights into the state of play, challenges, solutions and opportunities occasioned by Covid-19.
- 24. Completed the structural modifications of the Chancery premises including beefing up of security measures through the installation of security door between the arrival area and offices; fireproof; private lavatories; expansion of the waiting lounge and new front desk with mounted protective glass owing to the prevailing covid-19 pandemic. The work environment has become more conducive and security as well as Uganda's image at large is enhanced.

Provision of Consular services, and matters handled

- 25. Successfully repatriated the remains of Late Permanent Representative of Uganda to Geneva on 8 July 2020 following his demise on 10th June 2020.
- 26. Facilitated the return home of 16 Ugandans and 2 legal residents stranded in transit following the outbreak of the pandemic and subsequent closure of Entebbe Airport.
- 27. Attended the National Days of Switzerland, Ukraine, Brazil, Mexico.
- 28. Issued 19 visas composed 10 Multiple entry visas amounting to 1200 CHF; legalised 22 documents amounting 880CHF; and facilitated renewal of 7 passports.
- 29. Successfully attended to consular inquiries from 82M and 73F regarding procedures for passport renewal, and new travel restrictions resulting from the pandemic outbreak.
- 30. 86 Ugandans in total had formally complied with procedures of registering with the Permanent Mission in Switzerland; Conducted meet and greet diaspora mobilisation visits to Zurich, Soltorn, Riethiem and Basel Cantons.

X. Vote Challenges and Plans To Improve Performance

Vote Challenges

- 1. Covid-19 pandemic disruptions to activities such as UNCTAD under its project (1617K) on promoting cotton by-products in conjunction with URI and CDA could not complete the development of carbonized briquette technology i.e. value addition to the cotton stalks by close of the project on 31st December 2020.
- 2. Low staffing levels currently standing at 1+6 visa vis area of coverage. The Mission is accredited to the UN office and other International Organisations based in Geneva and Switzerland on a bilateral level. In a snap shot the coverage involves 33 International Organisations, of which 23 are Intergovernmental organisations and 8 UN agencies. Additionally, the Mission covers 250 Non-Governmental Organisations headquartered in Geneva as well as responsible for the Bilateral relations with Switzerland. An addition of two staff would be a good boost to enhance Mission effectiveness.
- 3. High costs of living compared to the non-competitive remuneration rates in form of salaries. This has been manifested by the Canton of Geneva announcing in November 2021, a new minimum hourly wage of CHF23 to mitigate the high costs.
- 4. Arrears in payment of assessed contribution fees to South Centre and WTO resulting in Uganda being placed under administrative measures including loosing of voting rights and shaming. This is negative publicity for the country's image.

Plans to improve Vote Performance

- 1. Continue to mobilize more Ugandans in Switzerland to Increase the investments in Uganda.
- 2. Engage Ministry of Finance, Planning and economic development on allocation of funds for operational purposes that we can use for purpose of commercial diplomacy and enhance the security of the mission and to be able carryout other activities.
