During the FY 2014/2015, the EOC applied for a supplementary budget of Shs. 204,003,934 for wage and was granted, as shown by the budget over performance of 113.4%. Attached is the supplementary funding schedule dated 25th May 2015. The Commission, as an independent organization needs to have clear systems, operational guidelines and manuals for smooth operation of the institution.

Few departments like Education, Training, Information and communications, Statutory and Legal services, Investigations and Compliance faced limited resources. This affected implementation of their departmental activities hopefully this will improve in the FY 2015/16.
