The Inspectorate of Courts recorded the following performance for half Year FY2022/23;

- i. 56 Country wide inspections carried out in all regions of Uganda in accordance with the Inspectorate check list
- ii. 16 adhoc field inspection conducted
- iii. 4 Disciplinary Committee meetings conducted.

3. Legal reference materials procured; 152 Uganda Civil Justice Bench Book and Uganda Criminal Justice Bench Book for newly appointed Judicial Officers (140), Bulamuli G1(1), Bujuuko G1 (1), Fort portal (10); Sets of red and blue sets of laws; Bulamuli G1(1), Bujuuko G1 (1), Mukono HC (4); Bible, Quran & Grey book for Mukono G1; Set of chancery Division Law Report (238 volumes) for Fort portal

Strategic Objective: To enhance equitable access to Judiciary Services

- i. The construction of the Supreme Court building was at 90% completion with the installation of air conditioning, door shutter fitting, plumbing fittings, and IT cabling going on while the Court of Appeal building was at 80% completion with the installation of air conditioning, shutter fittings and tiling going on.
- ii. The renovation of the Courts was as follows-Gulu High Court, Mbale High Court, Tororo CM, Katakwi CM, Pader CM, Oyam CM & Mbale CM are at finishing stage; the procurements for renovation of Mubende CM, Nakasongola CM, Apac CM & Mukono CM are awaiting the approval of the Solicitor General.
- iii. Construction of the High Courts was as follows; Soroti High Court at first floor slab casting; Rukungiri High Court was at second-floor slab casting and Tororo High Court at the submission of bills of quantities.
- iv. Construction of Chief Magistrates Courts was as follows; Alebtong, Lyantonde & Budaka are at roofing stage.
- v. Construction of the Magistrate Grade 1 Courts is as follows; Abim Court at ground floor slab casting, Patongo at plastering level and Karenga at superstructure walling.
- vi. The rehabilitation of Nabilatuk Magistrate Grade 1 Court was ongoing at finishing stage.
- vii. The expansion of Moroto Chief Magistrate Court was ongoing at tiling
- viii. Procurement of the 12 Air conditioners was as follows; 6 Air conditioners for Kampala HC, Arua HC & Arua CM were procured and installed and a Local Purchase Order was awarded and waiting for delivery of the 6 Air Conditioners for Gulu HC, Gulu CM & Masindi HC;
- ix. Procurement of 4 generators was as follows; a generator procured for Kabale HC, while procurement for Arua HC, Masindi HC & Judicial Training Institute was ongoing at tendering stage.

Strategic Objective: To strengthen the use of Information and Communication Technology

- i. 2 ECCMIS Change Management sessions conducted
- ii. 2 Court Recording and Transcription Systems procured for the 2 new High Courts of Luwero and Rukungiri

VI. VOTE NARRATIVE

Vote Challenges

1. Increasing caseload: Whereas commendable effort has been made in dealing with case backlog, the number of newly registered cases have consistently increased every passing year. For the year 2022 the newly registered cases across the Courts increased from 198,829 recorded in the year 2021 to 239,598 in the year 2022 hence an increase by 40,769 cases.

2. Inadequate manpower: Whereas the Judiciary have recruited a number of staff during the past two years, the process of recruitment is rather slow and the numbers are still insufficient to match the justice demands. The number of administrative and support staff has also not been increased to match the judicial offices, which has negatively affected justice delivery.

3. Inadequacies amongst some of the key justice Agencies: The other justice service Agencies such as the ODPP, the Uganda Police Force, the Judicial Service Commission and the Office of the Attorney General, among others have not taken sufficient steps in terms of stepping up their human resources, increasing their presence across the country and providing sufficient tools for their workforce. This has inevitably frustrated justice service delivery and made it difficult to banish case backlog from Courts.

4. Non establishment of the Judiciary Service: Whereas substantial progress has been made in fast tracking the independence of the Judiciary in line with Administration of the Judiciary Act 2022, the Judiciary has not yet fully established a Judiciary Service detached from the Public Service, defined and controlled from within the Judiciary. This affects its ability to exert full disciplinary control and manage expectations and welfare demands.

5. Corruption: While incidents of corruption have reduced within the Judiciary, the vice still looms. Some litigants and lawyers have on several occasions made attempts to solicit and offer bribes to court staff. Judicial officers continue to receive unsolicited calls demanding that decisions be made in a certain way and some court staff are accused of soliciting and accepting bribes in order to cause undesired results such as hiding files, removing some key documents from files, granting or denying bail or even deciding cases in a certain way.

6. Indiscipline of lawyers: There is a growing number of indiscipline litigants and advocates. In addition, there are delays by the Law Council to dispose of these disciplinary cases involving advocates. The Judiciary has also encountered a breed of advocates who exhibit tendencies of corruption, mislead their clients into making undue complaints to irrelevant offices and also illegal alternatives to court process. Some lawyers also refuse to follow the due process and use underhand means to obtain wrong ends. Some lawyers do not adhere to the professional code of ethics, in dress, decorum and etiquette and are fond of attacking judicial officers over social media and making endless recusal applications rather than follow the due process.

7. Poor road infrastructure and insecurity in some parts of the country: The road network in some places such as Buhweju, Kanungu, Bulambuli, Kaabong, among others have remained very poor, making accessibility of courts very difficult. Some places especially in the Karamoja region still face insecurity that threaten life and property which affect delivery of justice services.

8. Inadequate transport: The Judiciary still face a big challenge of inadequate vehicles to facilitate the work of judicial officers especially those at the lower bench and in hard-to-reach areas like the islands of Koome, Buvuma and Kalangala. The Judiciary lacks a water vessel to traverse the island.

9. Impudence and refusal to respect court orders: During the enforcement of court orders, some bailiffs execute court orders illegally for example with the use of excessive violence as well as executing court orders at night. In some other instances court orders are disrespected and interfered with during the

execution process by some members of the armed forces, some RDCs and even lawyers.

10. Insecurity of judicial officers and the courts: Judicial Officers and other justice service providers continue to receive threats from known and unknown sources. Attempts have been made at the lives of some judicial officers on the lives of some judicial officers, with some receiving consignments of live ammunition (bullets) and others having actual threats of violence being made to them on phones and in the media. Furthermore, some courts have been broken into and vital court property stolen, burnt or damaged. The Judiciary condemns this and undertakes to support its officers to by increasing their security.

11. Inadequate court infrastructure: Most of the court buildings are old, small and lack adequate facilities to match the staff and court user needs. Additionally, courts are operating from rented premises while other gazetted courts including some High Court Circuits lack premises to start operation

Plans to improve Vote Performance

1. Fast-track the recruitment of Judicial and non-Judicial Officers;
2. FastTrack the full implementation of the Administration of Judiciary Act that gives effect to Chapter Eight of the Constitution of the Republic of Uganda relating to the Judiciary.
3. Fast track the roll out of Electronic Court Case Management Information System(ECCMIS)
4. Increase automation of Court operations through procurement and installation of Video Conferencing facilities and Court Recording and Transcription Equipment.
