7,652 tons of solid waste was collected, transported and disposed at the Landfill. About 67% of the collected waste was disposed by KCCA and the rest by private garbage collectors. In comparison to the 4th quarter 2013/14, there was a 2% decrease in the total amount of solid waste disposed of at the landfill.

Out of 60 projects inspected and reviewed, 37 projects were recommended to NEMA for EIA certificates, 23 projects were not recommended to NEMA for EIA certificates. Four audit projects were reviewed. 62 noise pollution formal complaints were registered during the quarter. Of these, 40.32% of the premises were inspected and monitored, 33.87% were inspected and issued with improvement notices and 25.80% were forwarded before court for prosecution.

97 Amusement entertainment premises facilities inspected, 43 Nuisance notices (1st issue), 17 Enforcement / Prosecution generating UGX 11,700,000 as Court fines from 12 Facilities for not being compliant to National Environment (Noise standards and control) regulation 2003. Upon inspection the following outcomes were agreed upon by each division, Deadlines set to kick start enforcement, written minutes, ompliance were to cover facilities within the division by playing music/ producing sounds in permissible levels as part of the awareness raising and control of noise pollution
