By close of the FY, UGX 39.029 was released out of which UGX 38.485 was spent out.

CHALLENGES:

- The halt on recruitment resulted in non recruitment of staff leading to under absorption of the wage bill.
- delays in submission of the life certificates by some of the pensioners led to suspension from the pension payroll resulting into under absorption in the pension
- Delays in submission of the required documents by SOME gratuity Beneficiaries led to under absorption of Gratuity.
