Performance highlights for the Quarter

BUDGET PERFORMANCE

During Quarter one of FY 2024/25, MEACA received UGX 13.736Bn of which UGX 0.241M was wage, UGX 13.495 Bn was Non-wage and no funds were released for development. This was 33.6% of the total approved Budget. Out of the released Q1 Budget, only 97.4% of the release was spent. The major variations are mainly observed in Non-Wage. Out of the expected UGX 15.995 Bn approved for Q1, Only UGX 13.495 Bn was received. Out of the released funds, UGX 13.380 Bn was spent out and 0.356 Bn unspent (2.6% of what was released was unspent). The main reasons for under absorption of funds is because; - Delayed procurement processes, -Bounced payments due to invalid accounts and delayed submissions of life certificates by some Pension Claimants.

O1 KEY PERFORMANCE HIGLIGHTS

By close of Quarter one, ministry implemented the following; Coordinated & participated; 3 preparatory meetings on EAC tariff offer for the AfCFTA, EAPCE'25 & EALA; 3 EAC sectoral council engagements Extraordinary Session of Senior Officials on LVFO, 54th Extra Ordinary meeting & 45th Council of Ministers; 5 National consultative meetings on Elimination of NTBs, EAC Climate Change Policy & Strategy, EAC Blue Economy Strategy & Action Plan Pandemic Policy Framework and Other Health Instruments, & Trade in Services; 7 other Regional meetings across the various departments; followed on EAC commitments to ensure compliance with the CMP, council decisions & directives; 2 stakeholder engagements on EAC Social Protection Policy & women in cross border trade; Conducted 1 Capacity Enhancement for Small Scale Cross Border Traders, cleared 50% of the remittances towards EAC organs and institutions, assented to the Presidential directive on the National and Regional efforts on Karamoja Development.

Variances and Challenges

VARIANCE

The ministry has an annual budget of 40.916 Bn. The approved Q1 Cash Flow Plan is UGX 15.994 Bn, of which UGX 0.241M is wage, UGX 15.660Bn being Non-wage and UGX 0.093 is development. During the implementation of Q1 the Ministry received a Total Funding of UGX 13.736 Bn therefore creating a negative variance of 2.258 Bn. All Wage, pension, Gratuity & EAC contributions for the quarter were received, as per the Approved plan. Zero development funds were received and a negative variance of 2.258 Bn being uncounted under Non-Wage.

CHALLENGES

The negative variance of 2.258 Bn under Non-Wage resulted in non-implementation of many Q1 planned activities and the Zero (0) release under development funds affected the planned procurement of ICT and Furniture hence the procurement process in Q1 was not undertaken.
