UGX 41.066 was released by the close of the Quarter out of which UGX 40.934Bn was spent out by the end of the Quarter. the revised budget was higher than the approved budget mainly because of the Approved supplementary wage funding to close the wage funding gap experienced. By the close of the quarter, the absorption level was 100% with almost all released funds spent out save for a few funds that was left unspent for various reasons.

Variances and Challenges

Budget Variances:

- -During Budget execution of FY 2024-25, Ministry requested for a supplementary funding to cater for a salary deficit that was experienced when the Ministry's wage bill was reduced in consideration of the Special audit verification report on wage. It should be noted that the Audit report did not take into consideration the three officers who were not on the payroll at the time of the Special Audit Exercise as a result of deferment of the Nomenclature of the staff position in the current Staff structure. Issuance of the wage supplementary therefore resulted into the Revision of the Budget.
- -Equally out of the Revised budget of UGX 41.236bN only UGX 41.066Bn was released by closed of Quarter 4 and out of the Total release UGX 41.066 was spent out

Budget Execution Challenges:

The ministry experienced the following execution challenges;-

- i. Non convinement of some planned EAC regional engagements by the EAC Secretariat. The Secretariat experienced serious financial constraints during execution of FY 2024-25 budget resulting into postponement and cancellation of some regional engagements.
- ii. under release of funds especially in Quarter one that resulted into slow pace of implementation of planned activities.
- iii. Ministry continues to face the challenge of non participation of relevant MDA's in most of the regional engagements. this compromises the National negotiations
- iv. Introduction of some administrative reforms for example the introduction of EFRIS tax policy resulted into under expenditure of some funds .(Postage and Courier)
