Performance highlights for the Quarter

During Quarter one of FY 2023/24, MEACA received UGX 8.57Bn of which UGX 0.321M was wage, UGX 8.254 Bn was Non wage and no funds were released for development. This was 22.4% of the approved Budget. Out of the released Budget, only 80.2% of the released budget was spent.

The variations are mainly observed in Non Wage. Out of the expected UGX 15.65 Bn approved for Q1, Only UGX 8.57 Bn was received. Out of the released funds, UGX 6.67Bn was spent out and 1.696 Bn unspent (20% of what was released was unspent).

The main reasons for under absorption of funds is because;

- The EAC Calendrer of activities were deferred to the succeeding quarters due to delayed approval of the EAC Budget.
- Bounced payments due to invalid accounts and delayed submissions of life certificates by some Pension Claimants.

By close of Quarter one, ministry implemented the following; Coordinated and participated in the different EAC Sectoral Council regional engagements under the different sectors, Coordinated a regional workshop to validate the Regional Irrigation Development Strategy (RIDS) held in Nairobi , Coordinated signing of the MoU on the cooperation & implementation of cross-border measures to prevent & control trans-boundary animal disease, Participated in EAC–SACU Bilateral Meeting of Technical Experts, Participated in Uganda DRC Joint Permanent Commissions (JPC) , Participated in two National Consultative engagements, Participated in the 51st Trademark Africa National Oversight Committee meeting, Trained Ugandan business persons engaged in Cross Border trade to enhance their business transactions in Swahili was undertaken in July 2023, Translated key EAC Policy Instruments documents (The simplified Trade Regimes, Coordinated and attended in the 24th Sectoral Council on Legal and Judicial Affairs , Conducted one stakeholder engagement meeting on the Karamoja Development Programme to promote peaceful co-existence, & good neighborhoods. among others

Variances and Challenges

VARIANCE

The ministry has an annual budget of 38.361 Bn.

The approved Q1 Cash Flow Plan is UGX 15.861 Bn, of which UGX 0.321m is wage, UGX 15.325Bn being Non wage and UGX 0.215 is development.

During the implementation of Q1 the Ministry received a Total Funding of UGX 8.575 Bn therefore creating a negative variance of 7.286 Bn. All Wage was received, all the Planned pension funds for the Quarter was received and Gratuity funds was received as per the Approved plan. Zero development funds was received and a negative variance of 6.965Bn was uncounted under Non Wage.

CHALLENGES

The negative variance of 7.286 Bn under Non Wage resulted in non implementation of many Q1 planned activities and the Zero (0) release under development funds affected the planned procurement of ICT and Furniture hence the procurement process was not undertaken in Q1.
