National Agricultural Advisory Services (NAADS)

NAADS will work through the nucleus farmers/commercial farmers to support out- grower schemes to boost production of the strategic commodities such as macadamia, Hass Avocado and Tea

NAADS will work closely with other stakeholders to establish Regional Farm Service Centers (RFSCs)

The RFSC is a one-stop center where farmers can get access to extension services. agricultural inputs including seed, livestock, planting materials, agrochemicals, hired farm equipment among others and have access to value addition, agricultural finance and market linkages services

Support agriculture programs through strategic partnerships with the private sector and Faith Based institutions to promote mindset change and commercialization of agriculture

- Up to eight (8) Lead/ Nucleus farmer partnerships have been established on Macadamia and Hass Avocado, starting with large scale commercial farmers who were already involved in the two commodities on their own/private initiative and were qualified via expression of interest based on the eligibility criteria.

- Put in place three (3) year framework contracts between the NAADS Secretariat and the Lead/nucleus farmers intended to ensure provision of quality planting materials for the two strategic commodities, have been put in place.
- Initiated sensitization and mobilization of farmers/farming communities and other commodity value chain actors and key stakeholders and is ongoing. This has resulted in increased demand within and outside the participating pioneer DLGs.

-Delivery and distribution of Hass Avocado and Macadamia seedlings to participating farmers out growers through the earmarked Lead/ Nucleus farmer partners commenced on a relatively small-scale during Season 2022B and will be scaled up during Season 2023A. A total of 96,573 Hass Avocado seedlings to establish 603.5 acres and 10,700 Macadamia seedlings to establish 107 acres had been distributed during Season 2022B. - Finalized development of detailed designs, cost estimates and procured civil works for construction of key infrastructure for establishment of Kapeeka Regional farm Service Centre (RFSC). MoU between NAADS and NEC for construction works for Regional Farmer Services Centre developed and works to be done during the FY.

NAADS in collaboration with relevant - Develop and scale up partnerships with line MDAs&LGs will partner with large scale commercial farmers (especially those with chunks of land) value chains of identified strategic high-value commodities with high national, regional and international demand. Some key strategic commodities have been identified in this regard including but not limited to Macadamia, Hass Avocado, Tea, Oil Seeds (sunflower and sova beans)

- NAADS will continue supporting organised farmer groups by building their capacity on key aspects of production and agri business/enterprise development. Commodity/enterprise-based farmer groups within commodity clusters will be promoted in order to have improved access to high quality inputs, relevant technical knowledge and skills through training, market information and as well as access to profitable markets.
