Performance highlights for the Quarter

1. National Council for Higher Education accredited a total of 145 programmes in Q4 of financial year 2024/25.
2. National Council for Higher Education conducted 10 facilities verification for STEM/STEI programmes from higher education institutions.
3. National Council for Higher Education trained 25 institutional managers and owners of higher education institutions in strategic leadership and management.
4. National Council for Higher Education monitored 70 institutions of higher learning in Q4.
5. National Council for Higher Education trained 25 programme and institutional assessors from higher institution of learning.
6. A total of 45 STEM/STEI programmes were accredited by National Council for Higher Education in Q4.
7. National Council for Higher Education conducted and published a survey report on the state for higher education in Uganda.
8. National Council for Higher Education conducted and published tracer study report STEM/STTEI Masters programme.
9. National Council for Higher Education published Higher Education Review Journal of the National Council for Higher Education.
10. National Council for Higher Education held a regional Annual Higher Education Conference in Mbarara city.
11. National Council for Higher Education held a regional Annual Higher Education Exhibition at Kamukuzi Grounds in Mbarara.
12. National Council for Higher Education developed 12 minimum standards for courses of study from higher institutions of learning.
13. A total of 440 foreign qualifications were equated by National Council for Higher Education.
14. A total of 120 local qualifications were recognized by National Council for Higher Education in Q4.

Variances and Challenges

1. National Council for Higher Education faced logistical challenges. National Council for Higher Education has 5 field vehicles, 2 of the vehicles are beyond the 5 years and due for disposal. This leaves NCHE with 3 vehicles to oversee 258 higher institutions of learning located through out the country.
2. There was no provision for funding for the National Council for Higher Education Infrastructural Development (Main Building). The inadequate funding negatively impact on the implementation of planned activities.
3. Limitation of the current Universities and Other Tertiary Institutions (UOTI) Act, Cap.262 which cannot allow full and quick implementation of NCHE mandate.
