III. MAJOR ACHIEVEMENTS IN 2024/25

- 1. Provision of leadership in development of the Policy on Government Accommodation
- In a bid to provide leadership in the implementation of Government Office accommodation Policy, the Office of the President coordinated the process of development of the Government Campus at Bwebajja. Since the initiation, the following has been done: the Environmental-Socio Impact Assessment ESIA and Feasibility Study; Physical Development Plan; Topographical and Cadastral Survey and the Traffic Impact Assessment TIA. Presently, the Preliminary Schematic Designs A3 stage to allow the Design Consultant proceed to the final Architectural and Engineering Designs have been concluded. This project is expected to reduce government expenditures on renting office space which has been growing at 12 percent per annum and threatening to become unsustainable.
- 2. Provision of technical support to the Cabinet in the discharge of its Constitutional role of determining and formulating government policy for national development.
- a. Supported the consideration and discussion of 49 Cabinet Memoranda by the Cabinet, including status update and viability of the Tea Industry in Uganda, management of the end of UMEME limited concession and retransfer of the Distribution network to Uganda Electricity Distribution Company Limited, transition and interim actions on the A level curriculum and the Mortgage Refinance Institutions Bill, 2024.
- b. Supported Cabinet to consider and approve 16 Bills for implementation including Bills to give effect to the Rationalization of Government Agencies and Public Expenditure RAPEX, Forensic Evidence Bill 2024, Public Service Pension Fund Bill 2024, National Sports Amendment Bill 2024, The Valuation Bill 2024, Mortgage Refinance Institutions Bill 2024, and the building control Amendment Bill 2024.
- c. Monitored and evaluated the implementation of 20 Cabinet Decisions under Minutes 12 CT 2022, 46 CT 2022, 57 CT 2022, 109 CT 2022, 117 CT 2022, and 126 CT 2022 to establish the status and progress of Cabinet Decisions as directed by the Cabinet including; Cabinet Decisions on Kampala Smart City Initiative, Exporting Pineapples, Indian proprietors of Mayuge industries, Batwa, Oil Palm production, Sango Bay, National Identification, monitored.
- 3. Coordinate the operationalization of the Intelligent Transport Monitoring System.

The Office continued to fast-track the implementation of the ITMS. On 1st November, 2023, the implementation of the Digital Number Plates was rolled out starting with Government Vehicles. Since then, the Project has rolled out to cover newly imported private motorcycles on 1st November, 2024 and to private motor vehicles on 6th January, 2025. So far 35,685 motor vehicle and motor cycles have been installed with the security enhanced numberplates broken down as follows 2,437 Government vehicles and motor cycles; 4776 private vehicles and 28472 motorcycles.

4. Formulation of the Regulation of the Interception of Communication Regulation, 2023

The Office of the President through the Ministry of Security coordinated consultative engagements and facilitated the policy formulation of the Regulation of the Interception of Communication Regulation, 2023 that seeks to address the irregular use of Sim-Cards. The Regulations provide for the lawful interception and monitoring of certain communications in the course of their transmission through telecommunication, postal or any other related service

or system in Uganda.

5. Enhancing security and good neighborliness for national development

The Office promoted 02 cross-border relations between the Government of Uganda and South Sudan at the Nimule Border point in August 2024 to discuss the Northern Corridor Integration Project and at the Elegu Border point in July 2024 to discuss cross-border trade issues.

6. Monitoring the implementation of Government programmes and projects.

The Office produced 01 Inclusive Status Report on the implementation of the previous APEX Platform recommendations on the 23 Presidential Strategic Guidelines and Directives. The findings of the above follow up exercise showed that 03 Directives have been fully attained including Directive 8 on granting the necessary license for oil and gas; Directive 14 on establishing the National airline and Directive 17 on gradually improving the working conditions of the judiciary, while the remaining 20 Directives are on course.

7. Monitoring the implementation of the NRM Manifesto commitments by all MDAs.

The Office conducted the Manifesto Accountability Week of 2024 from 15th November to 5th December 2024. The week provided an opportunity to celebrate and take stock of the cumulative milestones and achievements of the government in the implementation of this social contract. Preliminary findings indicated that 35% of the Manifesto targets were achieved, 49% are on track and 16% are not yet implemented.
