III. MAJOR ACHIEVEMENTS IN 2022/23

- i. During the the 1st half of FY 2022/23 the authority managed to attract two (2) Developers and Operators which were licensed increasing the total number of Free Zones to 33 which were projected to invest US\$ 503 Million.
- ii. Construction works at Entebbe International Airport Free Zone are ongoing; Overall Project completion was at Approx. 40% by December 2022, Works on Trade House Foundation commenced, Southern embankment wall construction works were completed, Trade House Foundation & additional Production Unit 2 works were completed.
- iii. In the Half year of 2022/23 756 new Jobs were created by Free Zones cumulatively.
- iv. The export earnings from the Free Zones were US\$ 27,518,410 out of which only USD 47,128.were processed gold exports during the period ending December 2022.
- v. The actual investment generated by Free Zones in the half year ending December 2022 was at USD 30,984,938.
- vi. The local purchases and sub-contracting services were worth UGX 59,476,927,225 from Free Zones as backward linkages.
- vii. The Tax Revenue generated from Free Zones stood at UGX 8.735 Billion
