#### Performance highlights for the Quarter

In Q3 only UGX31.8bn out of the expected UGX108.7bn was released out of which UGX20bn was allocated for maintenance of national roads and UGX10bn allocated to KCCA and the rest of the designated agencies were left without maintenance funds.

The cumulative performance to Q3 stands at 60.7% as opposed to expected 75%. This has had a negative impact in road maintenance implementation with many roads left in deplorable state.

#### **Variances and Challenges**

In Q3 all the designated agencies except UNRA and KCCA never received funding for road maintenance. This has had a negative impact on the state of roads in the whole country with accumulation of road maintenance backlog.
