UNSPENT BALANCES AT THE END OF FY2024/25 MEANT TO FUND PROJECTS UNDER THE UGANDA INTER-GOVERNMENTAL FISCAL TRANSFERS (UGIFT) PROGRAM

- 1. In FY2024/25, this Ministry released funds for construction projects under the Uganda Inter-Governmental Fiscal Transfers (UGIFT) Program.
- 2. However, due to contract management challenges, beneficiary Local Governments were unable to execute their projects on time. As a result, these funds were returned to the Consolidated Fund at the end of FY2024/25 in accordance with Section 17 (2) of the Public Finance Management Act 2015. Subsequently, this Ministry has received requests from 37 Local Governments requesting a re-voting of the above unspent funds to enable them to complete their projects.
- 3. In regard to this matter, I wish to advise as follows:
 - a. All affected Local Governments should submit detailed reports on unspent balances for the UgIFT programme, including the budget for each project, the expenditure made by the end of June 2025 and a detailed project status report (with pictorial evidence). This information should be submitted by Friday, 15th August 2025, documents submitted must be initialed. Please note that those Accounting Officers who do not submit by this deadline shall be sanctioned; and,
 - b. The submitted information on the unspent balances shall be reconciled with existing available information on IFMS and



PBS to confirm accuracy. Premised on the findings, a supplementary budget shall be processed in line with the returns, to fund the completion of any ongoing works that were supposed to be done by the end of FY2024/25.
