WARRANTING AND INVOICING OF FOURTH QUARTER EXPENDITURE LIMITS FOR FY 2016/17

As you are aware, Government in July 2016, made a decision to have all releases done under the IFMS. All votes under Legacy system had to shift to IFMS (Ref. BPD 86/268/01 circular on 21st July 2016). This implied that the Accounting Officers were included in the processes for the release of funds to Local Governments.

In January 2017, this Ministry held a training to orient Local Governments on how to prepare warrants and invoices in order to allow your cost centres access the third quarter releases. After the exercise, a number of you raised concerns over the adequacy of the one day training to enable you fully take over these tasks in the subsequent quarters. In order to address your concerns, this Ministry will continue supporting you quarterly at the IFMS centres, starting with Fourth Quarter FY 2016/17.

The purpose of this letter therefore, is to inform you that IFMS support Teams will be at the IFMS regional Centres between the 10th and 21st April 2017 starting at 8:00am to provide technical assistance during this exercise to enable you warrant and prepare invoices for the Fourth Quarter Expenditure Limits. Attached is a schedule showing date and venue for each Local Government.

You are requested to facilitate yourselves for this exercise.
